# IOM's Ambition

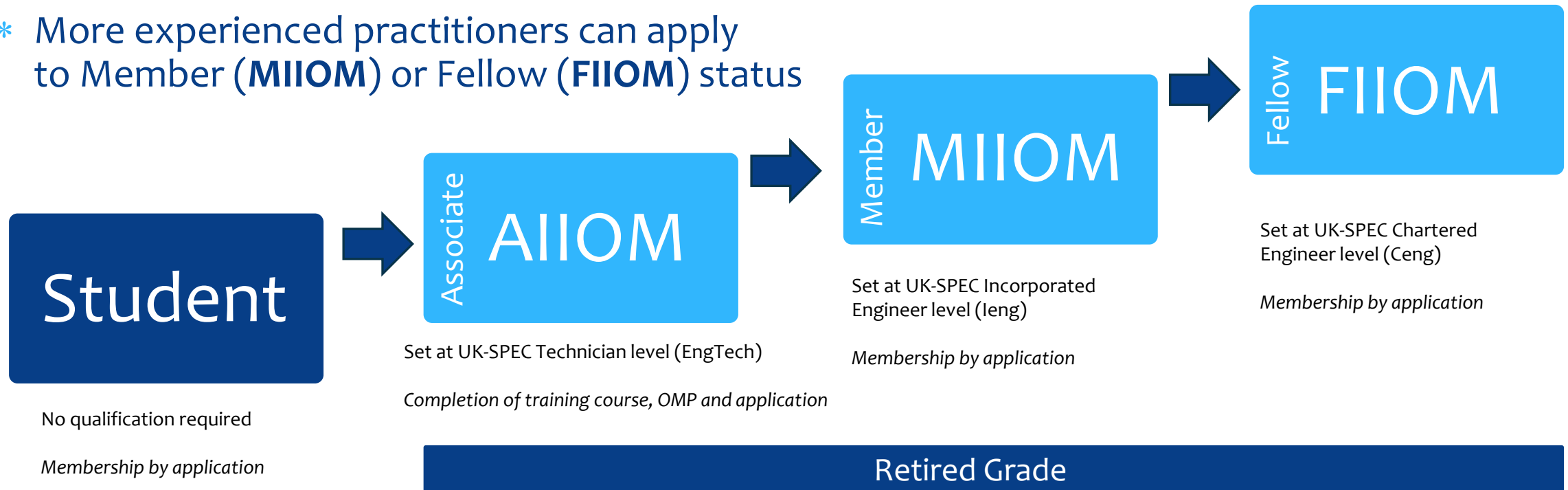
- \* IOM seeks to promote and support the adoption of Obsolescence Management **best practices** and actively promotes the **professional development** of its individual members.

# IOM's membership

- \* IOM seeks to promote and support the adoption of Obsolescence Management best practice and actively promotes the professional development of practitioners the individual members of IOM
- \* The education, training and experience that practitioners typically undertake enables them to work in accordance with Internationally recognised standards in such as IEC 62402:2019
- \* IOM has developed a competence framework where essential competencies are defined at the Associate (AIOM), Member (MIOM) and Fellow (FIIOM) grades of membership

# Development ladder

- \* IOM accredited trainings for those at the early stage of their career leading to Associate (**AIIOM**) status
- \* More experienced practitioners can apply to Member (**MIIOM**) or Fellow (**FIIOM**) status



These arrangements are consistent with UK Engineering Council requirements (UK-SPEC) and recognised internationally

# Professional development - key benefits

- \* Individuals will be able to **demonstrate competence and experience** to current and prospective employers, e.g., via post nominal letters.
- \* Enables **international mobility**, e.g., can be particularly useful in the context of international projects. Obsolescence is also a **cross-industry** discipline.
- \* IOM members will have a route to **Professional Registration** with the UK Engineering Council.
- \* EngTech, IEng and CEng professional registration with the **UK Engineering Council** is widely recognised throughout the world.
- \* The **UK Engineering Council** is also the UK signatory of international agreements concerning engineering education and registration and can receive applications for European Engineer (EUR ING) registration.

# Associate grade (AIIOM)

- \* To obtain membership of IIOm at Associate level, the Institute requires candidates to have successfully passed a training course delivered by an endorsed training provider:

- \* Criteria for **MIOM** and **FIIOM** are based on assessment of the applicant's learning, experience, responsibilities, and achievements (no exams).
- \* Options for Membership (**MIOM**) and Fellowship (**FIIOM**) were benchmarked with other UK institutions including the **IET, BCS, IMechE**.
- \* **Application forms**, supporter's forms, and guidelines have been produced by the Professional Standards & Membership Committee and IOM International Board.

In Part B please provide details of your education. The Committee will need to see evidence of educational attainments, e.g. certificates, either as scanned files in PDF format or paper copies. Do not send original certificates.

If you do not have an educational qualification at degree level this will not necessarily prevent a successful application. However, all MIIOM applicants are expected to provide information in Parts C and D that demonstrates responsibilities and achievements commensurate with those of a graduate with two to three years' professional employment within industry or academia.

In Part E give contact information for up to two supporters who are willing to support your application by confirming the information you gave in Parts C and D.
